# **SKKA IDT ALERT**

## **KEY HIGHLIGHTS:**

1. In case of a proprietorship concern, the Permanent Account Number of the proprietor shall also be linked with the Aadhaar number of the proprietor.

2. If no Aadhar has been assigned to those who are required to undergo Aadhar Authentication then such person must furnish following documents: Aadhar enrollment ISD & Bank Passbook or Voter id or Passport or Driving License.

Such person shall undergo the authentication of Aadhaar number within a period of thirty days of the allotment of the Aadhaar number. (As per Rule 10B)


3. As per Section 25(6A), in case of failure to undergo Aadhar Authentication, registration shall be deemed Invalid.

# **AADHAR AUTHENTICATION:**

Aadhaar authentication is a process by which the Aadhaar number along with other biometric details of the Aadhaar holder are submitted to the Central Identities Data Repository (CIDR) for verifying the user for his desired action. The main purpose behind the Aadhaar Authentication under GST:

To keep a check on the malpractices happening

# **IMPLEMENTATION:**



Aadhar authentication for new registration has been brought into the light to improve the smoothness of doing business for genuine businesses. (refer **Notification No 62/2020-CT dt 20.08.2020**).

In the  $45^{\text{th}}$  meeting of the GST Council, held on 17/9/21 certain measures had been undertaken for Streamlining compliances in GST i.e Aadhaar authentication of registration to be made mandatory for – (a) Being eligible to file refund claim and (b) Application to revoke cancellation of registration.

Rule 10B which was notified vide Notification No.35/2021 dated- Central Tax dated 24.9.21 but the date from which the provisions of this Rule will be made effective has been notified vide Notification No.38/2021- Central Tax dated 21/12/21.

Rule 10B of CGST Rules shall be inserted with effect from 1.1.22 which prescribes compulsory Aadhaar authentication for registered person (as specified in table below) in order to be eligible for following purposes:


- 1. Filing of Revocation Application under Rule 23
- 2. Filing of Refund Application under Rule 89
- 3. Refund under Rule 96 on IGST paid exports

## **Process of Aadhar Authentication for Existing Taxpayers:**

Login to GST Portal with valid Credential i.e User ID & Password. Go to View Profile option and select Aadhar Authentication Status tab from Quick Links.

## SEND AADHAR AUTHENTICATION LINK OR UPLOAD E-KYC DOCUMENTS

In case the taxpayer selects the option, **SEND AADHAAR AUTHENTICATION LINK**, the color of tab changes from blue to green and the Aadhaar Authentication Status page is displayed. The Aadhaar Authentication Status page displays the list of Promoters/ Partners and Primary Authorized Signatory. Select the Promoter/ Partner for Aadhaar authentication by selecting the check box in Select for Aadhaar Authentication column.





Once you have clicked on **SEND AADHAAR AUTHENTICATION LINK**, an authentication link will be shared on GST registered mobile number and e-mail IDs of the Promoters/ Partners and Authorized Signatories. Aadhaar authentication link will be received on e-mail IDs of the Promoters/ Partners or Authorized Signatories as mentioned in the registration application and is valid only for 15 days.

Click the authentication link received on GST registered mobile number and e-mails IDs of the Promoters/ Partners, Authorized Signatories. Select the **Consent for Authentication**. Enter your **VID** or **Aadhaar Number**



#### PLEASE NOTE:

- Until the authentication is completed, the taxpayer will receive three Email reminders for Aadhaar authentication on 5th, 10<sup>th</sup>, and 15th day from the date of generation of Aadhaar authentication link.
- Aadhaar authentication link will be received on e-mail IDs of the Promoters/ Partners or Authorized Signatories as mentioned in the registration application of the GST and is valid only for 15 days.
- Please note you will receive common OTP on mobile number and E-mail ID linked with your Aadhaar for its authentication.
- If Aadhaar authentication link is used once for authentication, same authentication link cannot be accessed again.

#### (b) In Case second Option UPLOAD E-KYC DOCUMENTS is selected

#### To upload E-KYC documents, click the UPLOAD E-KYC DOCUMENTS tab.



Clicking the tab, turns the color of tab from blue to green and the details of both the Promoter/ Partner and Primary Authorized Signatory are displayed.

#### **PLEASE NOTE:**

- Once taxpayer has uploaded the documents by clicking on **UPLOAD DOCUMENTS**, an ARN will be generated for this and it will go to Tax Official dashboard. The Tax Official can either approve or reject the documents.
- If Tax Official approves the document, then taxpayer will be considered E-KYC Authenticated and not Aadhaar Authenticated.
- Thereafter if taxpayer himself wishes to authenticate Aadhaar subsequently, the taxpayer can do so by navigating to **MY PROFILE** > **AADHAAR AUTHENTICATION STATUS** > **SEND AADHAAR AUTHENTICATION LINK**. Taxpayer won't be able to upload documents again after they have been once approved by the Tax Official. However, taxpayer can view the document uploaded in Upload E-KYC Document column.
- Till the time Tax Official doesn't take any action on the ARN, taxpayer won't be able to upload documents again.

**REMARKS:** The government has made Aadhaar authentication mandatory for taxpayers to be able to claim refunds. with the objective of preventing revenue leakage. The move will help in reducing cases of fraudulent refunds as only verified taxpayers will be able to obtain refunds now. The Central Board of Indirect Taxes and Customs (CBIC) has amended GST rules bringing in various anti-evasion measures, including disbursal of GST refunds only in the bank account, which is linked with same PAN on which Goods and Services Tax (GST) registration has been obtained. As the cases of frauds has taken an upsurge in recent times this one step of making Aadhar authentication mandatory will help the officers to keep track of revenue loss.
